

Tompkins Township
Minutes
April 7, 2022

The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John A. Tuttle, Sr. followed by the Pledge of Allegiance to the Flag of the United States of America. Members present in addition to Supervisor Tuttle were Clerk Melanie Curran, Treasurer Janine Baldwin, Trustee Michael Haydo, and Trustee Nancy L. Seydell. The minutes of all the **March, 2022 Board and Special meetings** were approved following a motion by Haydo, seconded by Baldwin. **Treasurer's report** was read as: Total disbursements of \$50,724.49, deposits of \$127,051.71, and a balance of \$1,175,699.79. The report was accepted and placed on file following a motion by Curran, seconded by Haydo. Motion carried. **Amend the Budget** - Moved by Curran, seconded by Haydo to approve a budget amendment of \$42,500 from ARPA funds to Fire Protection Account done prior to the fire truck payment, and \$1000 from Township hall to Building Inspections. Roll call votes: all yes. Motion carried. **Vouchers for the fire department** were read by Supervisor John A. Tuttle, Sr.

RESOLUTION: We hereby continue to use County National as our depository bank for the next fiscal year. Motion made by Baldwin, seconded by Seydell. Roll call votes: all yes. Motion carried.

RESOLUTION: Ordinance Enforcement Officer Position created and hired Dennis Steenrod. Resolution was read, and offered by Tuttle, seconded by Baldwin. Roll call votes: all yes. Motion carried.

Deputy and hourly compensation positions held in the township - Moved by Baldwin, seconded by Haydo to raise the rate from \$12 to \$14, effective immediately. Roll call votes: all yes. Motion carried.

Board of Review, Planning Commission, and Appeals Board rate per meeting from \$50 to \$55 – Moved by Tuttle, seconded by Seydell. Roll call votes: all yes. Motion carried.

Public Comment was opened at 8:42 p.m. No additional comments were received, and the meeting continued. Comments were addressed during the meeting also. Fourteen permits were issued this month for building activity. The meeting was adjourned approximately 8:44 p.m. with sixteen in attendance.
