Township Office Internet – Proposed changing service to Rural 4G with unlimited data through Digi Dudes with a cost of \$200 for new modem and cost of \$135 monthly, and prepay as necessary; Moved by Curran, seconded by Baldwin. Roll call votes: all yes. Absent: Haydo. Motion carried.

Resolution Property Tax Payment Designee 2019 moved by Baldwin, seconded by Seydell. Roll call votes: all yes. Absent: Haydo. Motion carried.

Recreation Plan Resolution moved by Curran, seconded by Seydell to adopt the updated Recreation Plan 2020- 2025. Roll call votes: all yes. Absent: Haydo. Motion carried.

Stump Removal by the parking lot - Moved by Tuttle, seconded by Seydell to remove the stump for a cost up to \$200 by Discount Tree, and prepay as necessary. Roll call votes: all yes. Absent: Haydo. Motion carried.
