Fire Committee Compensation – Curran moved to increase payment for Fire Committee members from \$50 to \$55, seconded by Haydo. Roll call votes: all yes. Motion carried.

Inspector Monthly Fees- Moved by Tuttle, seconded by Haydo to increase Building Inspector monthly fee to \$60, Mechanical Inspector to \$60, and hire Phil Beemer as Site Plan Inspector and Floor Plain Inspector at \$50.00 monthly fee. Roll call votes: all yes. Motion carried. Permit fees will stay the same.

<u>Public Comment</u> was opened at 7:55 p.m. Comments were received and the meeting continued. Thirteen permits were issued this month for building activity. The meeting was adjourned at 8:01 p.m. with six in attendance.
