Tire Collection preapprove and prepay Tim Curran 5 hours @ \$15 per hour. Moved by Tuttle, seconded by Baldwin. Roll call votes: all yes. Motion carried.

Township Hall Rules – Moved by Baldwin, seconded by Haydo to **not allow tape or tacks on painted walls** for renters effective immediately. Motion carried.
