Cleaning Township Hall – Moved by Tuttle to contract with Rhonda Jones to clean the township hall, seconded by Seydell. Rhonda will be paid \$25 per cleaning, and \$14 per hour for extra cleaning duties. Roll call votes: all yes. Motion carried. Effective June 15, 2022.

Building / Mechanical Inspector – (1) Moved by Tuttle to hire Coleman DeConick as a contracted Mechanical Inspector at a rate of \$60 per inspection and monthly fee \$50.00, seconded by Haydo. Effective June 13, 2022. Roll call votes: all yes. Motion carried. (2) Moved by Tuttle to hire Phil Beemer as a contracted Building Inspector at a rate of \$60 per inspection and monthly fee of \$50, per seconded by Haydo. Effective June 13, 2022. Roll call votes: all yes. Motion carried. Contractors shall submit to the Clerk copies of their licenses, liability insurance, and W-9.

Resolution – Partial Termination of Farmland Development Rights Agreement for Rogers: Resolution presented by Tuttle, second by Baldwin. Roll call votes: all yes. Supervisor declared the Resolution adopted.

Internet at the township offices: Due to technical difficulties, internet provider needs to be replaced. Moved by Tuttle, seconded by Baldwin to sign up with Frontier for internet. Roll call votes: all yes. Motion carried.

Signs for the Stewart Property Trails: Moved by Tuttle, seconded by Haydo to purchase and post signs on the Stewart Property Trails regulating motor vehicles, up to \$300 for signs and supplies. No motor vehicles allowed on the trails unless previously permitted by the township. Roll call votes: all yes. Motion carried.

Portable Toilets for the Farmers Market at the pavilion – Moved by Tuttle, seconded by Baldwin to authorize up to \$65 dump fee to provide portable toilets for the Farmers Market. Roll call votes: all yes. Motion carried.

<u>Public Comment</u> was opened at 8:31 p.m. Comments were received and the meeting continued. Five permits were issued this month for building activity.

The meeting was adjourned approximately 8:34 p.m. with five in attendance.
