The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John A. Tuttle, Sr. followed by the Pledge of Allegiance to the Flag of the United States of America. Members present in addition to Supervisor Tuttle were Clerk Melanie Curran, Treasurer Janine Baldwin, Trustee Michael Haydo, and Trustee Nancy L. Seydell. Pay all the bills and approve the post-audit bills as reported, moved by Baldwin, seconded by Haydo. Roll call yes votes: Tuttle, Seydell, Curran, Haydo, and Baldwin. No votes: none. Motion carried. **Public Comment** was opened at 7:18 p.m. Comments were received and the meeting continued.

Tompkins Freedom 5K Walk/Run - Motion to approve the July 13, 2019 event on the Stewart Property by Tuttle, seconded by Seydell. Motion carried.

Standish Road - Moved by Curran, seconded by Baldwin to pursue having Standish Road rated as a county road, and not local road due to the amount of traffic and use of the road. Motion carried.

2019-2020 Road Projects - Moved by Tuttle, seconded by Haydo to approve Snyder Road and Standish Road projects(\$57,194.15) as proposed by JDOT, approve prepayment of \$14,298.54, and transfer \$1000 from Contingency to Road budget account. Roll call votes: all yes. Motion carried.

Disc Golf - Moved by Tuttle, seconded by Haydo to approve temporary weekend disc golf projects on the Stewart Property trails with the assistance of Nate Yarborough. Roll call votes: all yes. Motion carried.

Additional Tabulator - Moved by Curran, seconded by Baldwin to purchase an additional tabulator for elections in the next fiscal year budget. Roll call votes: all yes. Motion carried.

Public Comment was opened at 8:20 p.m. No comments were received, and the meeting continued. Two permits were issued this month for building activity. The meeting was adjourned at 8:20 p.m. with eleven in attendance.
