May 11, 2023

The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John A. Tuttle, Sr. followed by the Pledge of Allegiance to the Flag of the United States of America. Members present in addition to the Supervisor were Clerk Melanie Curran, Treasurer Janine Baldwin, Trustee Nancy Seydell, and Trustee Mike Haydo. Motion for Zoning Hearing – Moved by Tuttle, seconded by Seydell to schedule a Public Hearing for June 8, 2023 regarding amend/repeal of large solar large solar energy systems in the Zoning Ordinance, portions of Ordinance 2019-1. Roll call votes: all yes. Motion carried.

Pre-pay and Approve Bills - Moved to prepay and approve cemeteries requesting historical donations (Pope Church, Tompkins, Lincoln-Pomeroy) by Curran, seconded by Seydell. Roll call votes: all yes. Motion carried. Moved to prepay and approve election wages for the May 2, 2023 Election by Curran, seconded by Baldwin. Roll call votes: all yes. Motion carried.

Road Contract for Dixon Rd. – Moved by Curran, seconded by Seydell to enter into contract with JCDOT for Dixon Rd. road reconstruction, and signed by the Supervisor. Roll call votes: all yes. Motion carried.

Tompkins Center Historical Society/ Application for Charitable Gaming License – Moved by Curran, seconded by Baldwin to allow the clerk to sign the application for Historical Society to apply for Charitable Gaming License. Roll call votes: all yes. Motion carried.

Public Comment was opened at 8:09 p.m. Comments were received and the meeting continued.

Fifteen permits were issued this month for building activity.

The meeting was adjourned at 8:25 p.m. with twelve in attendance.
