**Grant Writer for AFG Grant (Assistance to Fire Fighters Grant Program) FEMA** Moved by Curran, seconded by Seydell to allow the fire fighters to contract with a grant writer to assist in applying for FEMA grant monies. Rives approved paying half of the \$1500 cost, with \$750 Tompkins portion. Roll call votes: all yes. Motion carried.

**Rescue Truck Change Order Contract** Rives approved the same change order. Moved by Tuttle to approve the recommended change order to the rescue truck required by updating of the jaws in the amount of \$4,400.50, seconded by Haydo. Supervisors will sign the contract. Roll call votes: all yes. Motion carried.

**Recreation Plan Update** Draft was presented to the board and request for approval to move forward. Moved by Baldwin to move forward and plan required meetings, seconded by Seydell. Roll call votes: all yes. Motion carried.

**Jackson County Aerial Imagery Acquisition Project** Moved by Tuttle to participate in the Jackson County Aerial Imagery Acquisition Project 2020 at a cost of \$3075.00, and allow the Supervisor to sign the letter of intent, seconded by Seydell. Roll call votes: all yes. Motion carried.

**Region 2 Membership Request** Moved by Seydell to opt out again of membership, seconded by Haydo. Roll call votes: all yes. Motion carried.

**Hot Water in Restrooms** Moved by Tuttle, seconded by Haydo to approve upon receipt of an invoice, \$100 towards the cost of installing (plumbing and electrical) of the hot water heater for the restrooms in the township hall, payable to Tompkins Historical who hired the contractors. Roll call votes: all yes. Motion carried.

<u>Public Comment</u> was opened at 8:11 p.m. No additional comments were received, and the meeting continued.

Fifteen permits were issued this month for building activity.

The meeting was adjourned approximately 8:12 p.m. with seven in attendance.
