The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John A. Tuttle, Sr. followed by the Pledge of Allegiance to the Flag of the United States of America. Members present in addition to Supervisor Tuttle were Clerk Melanie Curran, Treasurer Janine Baldwin, Trustee Michael Haydo, and Trustee Nancy L. Seydell. Proposal 2 – Moved by Tuttle, seconded by Seydell to take a position as a township, post on the website, and communicate to our residents – Tompkins Township Board would like to encourage our voters to thoroughly read over the whole language of Proposal 2 and consider how it will affect elections and costs at the local level. **Our recommendation would be to vote “No” on Proposal 2.** Roll call votes: all yes. Motion carried.

The meeting was adjourned approximately 8:13 p.m. with eight in attendance.
