Township Hall Elm Tree Removal - Moved to hire Hudson Tree Service to remove the Elm tree at the east side of the parking lot for \$1200.00, and Hudson will cut the wood to removable pieces. Moved by Tuttle, seconded by Baldwin. Roll call votes: all yes. Motion carried.

Public Comment was opened at 8:00 p.m. No comments were received, and the meeting continued. Fourteen permits were issued this month for building activity. The meeting was adjourned approximately 8:01 p.m. with five in attendance.
