The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John A. Tuttle, Sr. followed by the Pledge of Allegiance to the Flag of the United States of America. Public Comment was opened at 7:21 p.m. Comments were received and the meeting continued.

County Non-Motorized Trail – Non-motorized plan of the City of Jackson, Jackson County, and the Region 2 Planning Commission was announced and Principal Planning and Project Managers requested the Township’s support of the plan. Moved to support the plan with no financial liability by Curran, seconded by Seydell. Motion carried.

Payroll Tax Deferral – Voluntary payroll social security tax deferral (not a tax cut) will not be done unless Congress passes legislation to make the deferral permanent.

Clinton Rd House – At this time the house belongs to the Township. Moving forward the Supervisor will be interviewing prospective investors or buyers who would like to renovate or demolish the home very soon. Stipulations under the recommendations of the Supervisor and Twp. Attorney will be required regarding progress of renovation or demolition. The previous owner will have an opportunity to remove personal belongings. Moved by Curran, seconded by Haydo. Roll call votes: all yes. Motion carried.

Public Comment was opened at 7:58 p.m. Additional comments were received, and the meeting continued.

Seventeen permits were issued this month for building activity.

The meeting was adjourned approximately 8:05 p.m. with sixteen in attendance.
