**Region 2 Planning Commission -** Moved by Curran, seconded by Baldwin to decline funding the County for Region 2 Planning Commission. Roll call votes: all yes. Motion carried.

**FEMA Grant Permission** – Resolution to approve application for FEMA Grant by Curran, seconded by Baldwin. Roll call votes: all yes. Motion carried.

**Fire Station Repairs** – W.E.S. Construction / Consulting LLC submitted a bid to repair 6 or 12 posts in the Fire Station. Motion was made to approve the bid for 12 posts to be repaired, and proposed total \$22,342.86 by Tuttle, seconded by Seydell. Roll call votes: all yes. Motion carried.

**Jackson Radio Control Flying Club** would like to lease 6 to 8 acres on the Stewart Property to create a landing strip for radio controlled planes. Tuttle moved to move ahead into discussion with Jackson Radio Control Flying Club, and create an agreement. It was proposed the Club would like to have a storage unit and lean to on the property and pay a fee for the term agreed upon. Seconded by Baldwin. Roll call votes: all yes. Motion carried.

<u>Public Comment</u> was opened at 8:19 p.m. Comments were received and the meeting continued. Sixteen permits were issued this month for building activity.

The meeting was turned over to the Deputy Supervisor, Officer-Elect Supervisor Chuck Woodburn, and he adjourned the meeting at 8:38 p.m. with twenty in attendance.
