**Tire Collection 2025** – County informed us no grant is available this year, after the Board already planned on a tire collection for the residents. Cost for the container would be \$2200 divided among the three townships participating, Tompkins, Rives, and Henrietta. Moved by Tuttle, seconded by Baldwin to approve up to \$1600 in case one of the other townships back out, because Tompkins would still like to provide this service to Tompkins residents this year. Roll call votes: all yes. Motion carried.

Playground Committee – Discussion occurred. Moved to table by Tuttle, seconded by Seydell. Motion carried.

**Townhall Kitchen Appliances** – Historical is moving in and out new appliances at no cost to the township. Donations are secured.

**Trash Pickup at the Townhall** – Discussion occurred. Motion was made to not provide trash pickup by Curran, seconded by Baldwin. Roll call votes: Yes, which means no garbage service: Curran, Baldwin, and Seydell. No, which means provide garbage service: Tuttle and Woodburn. Motion carried. No garbage service will be provided.

<u>Public Comment</u> was opened at 8:16 p.m. Comments were received and the meeting continued. Sixteen permits were issued this month for building activity.

The meeting was adjourned approximately 8:32 p.m. with six in attendance.
