The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. outside the township hall by Supervisor Chuck Woodburn followed by the Pledge of Allegiance to the Flag of the United States of America. Members present in addition to Supervisor Woodburn were Clerk Melanie Curran, Treasurer Janine Baldwin, Trustee Nancy L. Seydell, and Trustee John A. Tuttle, Sr. The minutes of the November 13, 2025 Regular Board meeting were approved following a motion by Seydell, seconded by Baldwin. **Treasurer's report** was read as: Total disbursements of \$119,477.73, deposits of \$16,492.33, and a balance of \$660,455.11. Resolution for Poverty Exemption 2026 – Moved by Tuttle, seconded by Baldwin to approve the resolution. Roll call votes: all yes. Resolution adopted.

2026-2030 Recreation Plan Resolution – Moved to adopt the Recreation Plan by resolution by Curran, seconded by Seydell. Roll call votes: all yes. Resolution adopted.

Appointment of Board Members - Planning Commission Member: Bradley Dunlap and Alan Southworth to appoint to a three year term; Board of Appeals appointments: Nancy Seydell and Doug Swartz to a three year appointment. Appointments moved by Woodburn, seconded by Tuttle. Roll call votes: all yes. Motion carried.

Fire Dept Stipend – Moved by Woodburn, seconded by Tuttle to give the fire fighters \$25.00 stipend annually. Discussion followed regarding how it was going to be done. Roll call votes: Seydell, Tuttle, Baldwin, and Woodburn. No votes: Curran. Motion carried.

Failed Inspection Fee – Moved to increase failed inspection fee from \$65 to \$70 by Woodburn, seconded by Seydell. Roll call votes: all yes. Motion carried.

Jackson County GIS Annual Contribution Request – Moved to decline the annual contribution by Tuttle, seconded by Baldwin. Roll call votes: Seydell, Curran, Tuttle, and Baldwin. No vote: Woodburn. Motion carried.

Public Comment was opened at 7:55 p.m. No additional comments were received, and the meeting continued.

Eight permits were issued this month for building activity.

The meeting was adjourned at 8:57 p.m. with six in attendance.
